### **ACHIEVEMENTS**

**Sept 2016-** Filed an appeal against use of forced anal examinations to prove sexual orientation in Kenya after our legal aid clients were subjected to the same in a case where they are charged with consensual carnal knowledge against the order of nature.

**April 2016-** Filed a petition to strike down sections 162 (a), (c), 163 and 165 of the Penal Code of Kenya which criminalize carnal knowledge against the order of nature.

**February 2016-** Won a criminal case against the state where along 16 others we had been charged with taking part in a riot after we held a demonstration and brought live pigs into parliament to illustrate the greed of our legislators.

**September 2015-** Filed a petition in the High Court of Mombasa against use of forced anal examinations to prove sexual orientation in Kenya after our legal aid clients were subjected to the same in a case where they are charged with consensual carnal knowledge against the order of nature. We lost this case and appealed.

**August 2014 -October 2015-** Led a campaign against a proposed Kenya Anti Homosexuality Bill including holding live TV debates with the drafter of the Bill and the leader of the anti-gay parliamentary caucus in the Kenyan parliament. The Bill was eventually defeated.

**2010- May 2014-** Jointly with other pan African activists we Successfully lobbied the African Commission on Human and Peoples Rights to pass a resolution condemning violence on grounds of real or perceived sexual orientation and gender identity. The resolution passed.

**Feb 2014** - Participated in the drafting of constitutional arguments against the Uganda Anti Homosexuality Act. The constitutional court eventually struck down this law.

**Feb 2014**- Started a picketing campaign outside the High Commissions of Uganda and Nigeria in Nairobi to protest the enactment of ant gay laws in those countries. Anti-riot Police eventually dispersed us.

**Sept. 2013** – Filed a petition at the Constitutional Court in Nairobi (*Eric Gitari Vs AG*) seeking remedies against the government's refusal to register the National Gay and Lesbian Human Rights Commission. Judgment was in our favor.

**Dec. 2012**- Jointly founded the National Gay and Lesbian Human Rights Commission and launched it with a public cocktail at City Hall, Nairobi.

**May 2011** - Launched Kenya's shadow research report on the human rights status of LGBTI persons in Kenya which report I researched and compiled whilst working as an LGBTI associate with the Kenya Human Rights Commission.

**May 2010** - Chaired and organized Kenya's first public celebration of the International Day against Homophobia (IDAHO) at the National Museum as the LGBTI program associate under the Kenya Human Rights Commission.
