Prevalence and Antimicrobial Sensitivity Patterns of Uropathogens in Wad Medani, Sudan: A Three Years, Cross-Sectional Study

Purpose: Urinary tract infections exert a significant negative impact on an individual's quality of life and cause significant economic and public health burdens. Therefore, this study was conducted to identify the common bacterial uropathogens associated with urinary tract infections in Wad Medani patients and their susceptibility to antibiotics.

Patients and Methods: This was a cross-sectional study. All urine samples were collected from patients at Wad Medani and investigated at the Pathology Center for Diagnosis and Research, Faculty of Medicine, University of Gezira, Sudan, from the 1st of January 2021 to the 15th of October 2023.

Results: A total of 2698 urine samples were analyzed during the three years study period, with a mean age of 45.29 ± 18.9 years. Among these patients, 1108 (41.8%) were positive for bacterial growth, and 888 (80.14%) were female. A total of 522 (47.1%) were gram positive bacteria (GPB), and 586 (52.9%) were gram negative bacteria (GNB). The most frequently isolated bacteria were *S. aureus* 42% (465/1108) and *E. coli* 38.5% (427/1108), while *P. aeruginosa* was less detected 3.4% (38/1108). Amikacin 91.5% was the most sensitive drug to isolated GPB, while cotrimoxazole 20.9% was the least sensitive drug. In particular, amikacin 94.1% (144/ 153) was the most sensitive drug to *S. aureus*, while cotrimoxazole 20.7% (80/386) was the least sensitive drug. Moreover, amikacin 91.5% was the most sensitive drug to the isolated GNB, while ampicillin 5.7% was the least sensitive drug. Notably, amikacin was the most sensitive drug to all the isolated GNB, and ampicillin was the least sensitive drug to all the isolated GNB.

Conclusion: This study reported a moderate uropathogen isolation rate of 41.8%. *S. aureus* and *E. coli* were the most frequently isolated bacteria, most of which were from female patients. Remarkably, amikacin was the most sensitive drug to isolated GNB and GPB.

Introduction

Urinary tract infections (UTIs) are one of the most prevalent infections caused by bacteria and can be detected in both community and healthcare settings.¹

UTIs exert a significant negative impact on an individual's quality of life and cause significant economic and public health burdens.² UTIs are a major cause of morbidity in older men and women of all ages and even in infant boys. UTIs are caused by both gram-negative and gram-positive bacteria (GPB) in addition to some fungi³, of these, uropathogenic *Escherichia coli* (*E. coli*) strains are the most common causative agent.^{4,5}

Antimicrobial resistance (AMR) is a challenge that impacts all countries, regardless of their financial standing or developmental level.¹ In particular, AMR is more severe in developing countries due to irrational antibiotic use and

inadequate infection prevention strategies.⁶ The AMR Global World Health Organization (WHO) report on surveillance states that Africa and Southeast Asia are the areas without functioning AMR surveillance systems.⁷

Recently, there has been an increase in the prevalence of uropathogen resistance to previously effective antibiotics,⁸ given that most UTI patients start to receive empirical treatment before laboratory results are obtained from urine culture.⁹ A previous study conducted in Sudan showed that multiple drug resistance was found in 90% of the isolated bacterial uropathogens.⁴

Understanding local patterns of antimicrobial resistance is crucial because it can guide empirical and specific treatment recommendations.¹⁰ Empirical management plans need to be updated on a regular basis to consider changing patterns of pathogen susceptibility.¹¹ However, no data have been published from the present study area. Therefore, this study was conducted to identify the common bacterial pathogens associated with UTIs in Wad Medani patients and their susceptibility to antibiotics, which might be extremely significant in establishing the most appropriate empirical antibacterial therapy.

Materials and Methods

Study Site Wad Medani, Gezira State, Sudan.

Study Design

This was a cross-sectional study.

Sample Size and Data Collection

All urine samples were collected from patients at Wad Medani and investigated at the Pathology Center for Diagnosis and Research, Faculty of Medicine, University of Gezira, Sudan, from the 1st of January 2021 to the 15th of October 2023; these patients were included in the study.

Inclusion Criteria

All patients were aged ≥ 18 years.

Exclusion Criteria

Patients aged < 18 years. Antibiotics were tested for less than 20% of bacteria. Antibiotics are not included in the Clinical and Laboratory Standard Institute (CLSI) guidelines for specific bacteria.¹²

Sample Collection and Laboratory Methods

Sample Collection

After the patients were instructed to clean their genitals, a freshly voided midstream urine sample (10–20 mL) was collected in a wide-mouthed sterile, dry, and leak-proof container.¹³ For patients with catheters, urine was aspirated directly from the catheter using a sterile syringe and needle and then deposited in a sterile container.¹⁴

Identification of the Isolated Organism

The collected urine samples were inoculated onto MacConkey agar and blood agar plates using a calibrated loop (0.001 mL).¹³ Cultures were incubated in an aerobic atmosphere at 37°C for 24 hours. A positive urine culture was defined as a colony count of $\geq 10^5$ CFU/mL for midstream urine.¹⁴ For all positive cultures, morphological characteristics, Gram staining, and confirmatory biochemical tests were used to identify the bacterial isolates. Gram-positive bacteria were identified by the catalase reaction, coagulase test, optochin test, bacitracin test, and hemolytic activity test on blood agar. Additionally, gram-negative bacteria (GNB) were identified by inoculation on MacConkey agar plates, followed by biochemical tests such as H2S production, indole production, utilization of citrate/carbohydrates, urease tests, and oxidase tests.¹³

Antimicrobial Susceptibility

The antimicrobial susceptibilities of the bacterial isolates were ascertained by Mueller–Hinton agar plates (Oxoid, England) using the Kirby–Bauer disk diffusion method according to CLSI guidelines 2020.¹² GPB isolates were tested against the following antimicrobials: Ampicillin (10 μ g), Cotrimoxazole (1.25/23.75 μ g), Tetracycline (30 μ g), Ciprofloxacin (5 μ g), Levofloxacin (5 μ g), Chloramphenicol (30 μ g), Ofloxacin (5 μ g), Amikacin (30 μ g), Nitrofurantoin (300 μ g), Norfloxacin (10 μ g), and Amoxicillin/Clavulanic (20/10 μ g),¹² while GNB isolates were tested against the antimicrobials previously mentioned as well as Ampicillin/Sulbactam (10/10 μ g), Ceftriaxone (30 μ g), and Cefotaxime (30 μ g).¹² The CLSI 2020 guideline breakpoints were used to interpret zone diameters.¹²

Quality Control

As part of the standard practice throughout the whole laboratory work process, quality control procedures were used to ensure the validity of the results. Before usage, the normal shelf life of the culture media, staining reagents, and antibiotic discs was examined.¹⁵ All culture plates and antibiotic discs were prepared and autoclaved at 121 °C for 15 minutes, after which the plates were kept at the stated refrigeration temperature. The standard reference bacterial strains were examined as a positive control on agar plates with antibiotic discs and biochemical assays.¹⁵ The samples were handled carefully by qualified microbiologists.

Variable Definition

Coliform: included bacteria species of genera other than E. coli and Klebsiella (Citrobacter, Enterobacter, Serratia, etc.).

Statistical Analysis

The Statistical Package for the Social Science (SPSS) version 27.0 was used to analyze the data. Qualitative data are presented as frequencies (percentages). Quantitative data are presented as the mean \pm standard deviation.

Results

Sociodemographic Characteristics

A total of 2698 urine samples were analyzed during the three years study period; 1998 (73.9%) were from female patients, 700 (25.9%) were from male patients, and the mean (\pm standard deviation) age of the study participants was 45.29 ± 18.9 years.

Bacterial Profile

In total, our results showed that 1108 (41.8%) of the urine specimens were positive for bacterial growth, of which 522 (47.1%) were GPB, while GNB accounted for 586 (52.9%). Female patients accounted for the vast majority of positive urine culture 888 (80.14%) and male accounted for 222 (19.86)%. In addition, most of the positive culture urine samples occurred at 2022 662 (59.7%). Integrated data from three years, as well as the overall distribution of GNB and GPB incidence, are shown in (Table 1).

Overall, *Staphylococcus aureus* (*S. aureus*) was the most frequently isolated bacteria 42% (465/1108), most of which was isolated from female patients aged 45–59 years 140 (15.76%), and the least incidence in male patients aged 18 –29 years 10 (4.54%), as shown in (Table 2). *E. coli* was the second most common bacteria isolated 38.5% (427/1108), most of which were obtained from female patients aged \geq 60 years 100 (11.26%), and male patients aged 45–59 years were the least 6(2.73%) incidence (Table 2). *Pseudomonas aeruginosa* (*p. aeruginosa*) 3.4% (38/1108) was less detected bacteria, most of which were isolated from male patients aged \geq 60 years 12 (5.54%) (Table 2). With respect to GPB, our data revealed that *S. aureus* was the most abundant bacteria, while *E. coli* was the most common bacteria isolated from GNB (Table 1).

Antimicrobial Susceptibility Profile

The obtained data showed that out of 15 drugs were tested. Regarding GPB, our data showed that amikacin 91.5% was the most sensitive drug to the isolated GPB, followed by chloramphenicol 78.2%, while cotrimoxazole 20.9% was the

least sensitive drug to GPB (Figure 1). Concerning *S. aureus*, amikacin 94.1% (144/153) was the most sensitive drug, followed by chloramphenicol 76% (146/192), while cotrimoxazole 20.7% (80/386) was the least sensitive drug (Table 3). On the other hand, *Streptococcus* species (spp) showed the highest sensitivity to chloramphenicol 92.85% (26/28), and the least sensitivity to cotrimoxazole 22% (11/50) (Table 3).

Regarding GNB, our data showed that amikacin 91.5% was the most sensitive drug to the isolated GNB, followed by chloramphenicol 83.8%, while ampicillin 5.7% was the least sensitive drug to GNB (Figure 2). Notably, amikacin was the most sensitive drug to all isolated GNB. Which showed 91.2% (239/262) sensitivity to *E.coli*, 89.3% (25/28) to *P. aeruginosa*, 90.7% (39/43) to coliform, and 97.7% (43/44) to *Klebsiella* spp. Other remarkable results showed that ampicillin was the least sensitive drug to all isolated GNB. Which revealed 6.2% (13/210) sensitivity to *E.coli*, 9.5% (2/21) to coliform, and completely resistant to *Klebsiella* spp (0/31) as represented in (Table 4).

Discussion

Although UTIs continue to be one of the most prevalent illness patterns identified globally, treating UTIs has become more difficult as a result of the increasing development of antibiotic resistance.

Overall, the results of this investigation showed that the uropathogen isolation rate was 41.8%, which is considerably in agreement with that reported in a study conducted in Pakistan 36.1%.¹⁶ However, this isolation rate was more than two studies were conducted in Addis Ababa, Ethiopia, and Yamen reported isolation rates of 9.8% and 18%, respectively.^{17,18} In addition, a study conducted in Khartoum, Sudan, revealed an isolation rate of 19.5%.¹⁹ A significantly greater isolation rate of 71% was reported in a study conducted in Dhaka, Bangladesh;²⁰ this difference might be related to variations in the study population and geographical region.

The majority of isolated bacteria in this study were GNB, as has been noted in the majority of studies carried out elsewhere in the world. Our findings were in line with those of a study conducted in Pakistan, which showed that GNB were predominant;¹⁶ a study performed in Irbil, Iraq, revealed that most uropathogens were GNB 82.44%.²¹ Moreover, a study conducted in Addis Ababa, Ethiopia, reported that GNB were responsible for 84% of UTIs.¹

Overall, in the present study, *S. aureus* was the most frequently isolated bacteria, followed by *E. coli*. The prevalence of these bacteria among UTI patients may not be surprising, given that *S. aureus* is found within the skin's normal flora;

therefore, they can easily colonize the urinary tract and lead to infections, while *E. coli* is the most prevalent bacteria in the gastrointestinal tract and colon, from where it ascends to the urinary system and exploits its well-established virulence characteristics to colonize the urinary tract. The findings of this study were different from those of most published studies reporting that *E. coli* was the most predominant isolate. In two different hospital based studies conducted in Khartoum, Sudan, the most isolated bacteria were *E. coli* and *Klebsiella pneumoniae*.^{4,19} This variation might be linked to the difference in the study patients and settings, given that our study was laboratory based and encompassed outpatients and inpatients. Another study performed on outpatients at a tertiary care hospital in Pakistan revealed that *E. coli* 68.9% was the leading uropathogenic bacteria, followed by *Klebsiella pneumoniae* 8.9% and *S. aureus* 6.7%.¹⁶ Furthermore, a study carried out in Addis Ababa, Ethiopia, showed that *E. coli* was the most commonly isolated 50% followed by *Enterococcus* spp at 12% and *Enterobacter* spp. at 12%.¹ This variation might be correlated with differences in study patients and settings.

Our study showed that female patients accounted for the vast majority of the positive urine cultures. This finding was supported by several studies worldwide; of those, a study conducted in Khartoum, Sudan, revealed that females accounted for 60% of UTI patients.⁴ In addition, a multicenter study conducted in Eritrea showed that 64.9% of UTI patients were female.²² Another study carried out in Al-Kut, Iraq, reported that 84.88% of the study population were female UTI patients.²³ Furthermore, a study conducted in Madinah, Saudi Arabia, showed that the percentage of female patients 52.1% was slightly higher than that of male patients 47.9%.²⁴ It is commonly recognized that women are more likely to develop UTIs because of the anatomical and physiological features of the urinary tract.²⁵

In our study, there was a progressive increase in the incidence of positive urine culture with female age during the entire study period. These findings were supported by a review study covering all aspects of UTIs, from prevalence to management, revealed that the incidence of UTIs in women increases proportionately with patient age, exceeding 10% annually for women older than 60 years.²⁶ Moreover, comprehensive observational research on UTIs in older individuals conducted in the United Kingdom revealed that in women, the incidence of UTIs increased from 11.4 to 14.3% in individuals aged 75 to 84 years and from 9 to 11% in individuals aged 65 to 74 years.²⁷ Furthermore, in a study conducted in India, the occurrence of UTIs in females increased from 9% at ages 18–30 to 24% at ages >45 years.²⁸ A study that examined why UTIs are more common in elderly women revealed that there are several risk factors, such as hormonal factors (hypoestrogenism leading to genital atrophy), anatomical alterations (uterine prolapse), and functional changes (urinary incontinence).^{25,29}

In particular, the prevalence of *E. coli* among female patients was greater than that among men, and the highest rate was detected after 60 years of age. This result was in line with a study conducted in Brazil that reported that the prevalence of *E. coli* in women was 1.5 times greater than that in men.³⁰ In addition, a study conducted in Bangladesh revealed that the prevalence of *E. coli* was 63.6% in women and 36.4% in men.³¹ Moreover, this result was in agreement with a study conducted in Peshawar, Pakistan, which reported that the prevalence of *E. coli* in female patients was 72.7%.¹⁶ The high prevalence of *E. coli* in females might be linked to the fact that *E. coli* lives in the periurethral area and the shorter distance between the anal opening, the vaginal cavity and the urethra.²⁵

Regarding GPB, amikacin, chloramphenicol, and ciprofloxacin were the most sensitive drugs to isolated GPB, while the least sensitive drugs were tetracycline and cotrimoxazole. This finding was different from that of a study conducted in Bahir Dar, Northwest Ethiopia, in which the most sensitive drugs to GPB were ciprofloxacin 77.8%, penicillin 72.8%, and erythromycin 72.7%.³² However, a study conducted in Addis Ababa, Ethiopia, revealed that GPB exhibited 100% total resistance to penicillin.¹⁷ Furthermore, a study conducted on diabetic patients in al-Kut, Iraq, showed that gentamicin 11%, teicoplanin 6% and, vancomycin 6% were the most sensitive drugs, while oxacillin 49%, tetracycline 46%, and trimethoprim/ sulfamethoxazole 45% were the least sensitive drugs.²³ This variation could be related to the regulation of antibiotic use and policies, in addition to the difference in the frequency of each antibiotic used among countries.

In particular, for *S. aureus*, amikacin was the most sensitive drug, followed by chloramphenicol, levofloxacin, and ciprofloxacin. This result contradict that reported previously in Shandi, Sudan, which showed that gentamicin was the most susceptible drug to *S. aureus*, followed by ceftriaxone, while the most resistant drugs were ceftazidime and cloxacillin.³³ In addition, a study carried out in Yemen revealed that the drugs most susceptible to *S. aureus* were cefepime, ampicillin, and nitrofurantoin.¹⁸ Furthermore, the results of our study contradict those of a study conducted on Romanian female patients, which revealed that linezolid, levofloxacin, and nitrofurantoin were the most sensitive drugs for *S. aureus*.³⁴ Moreover, a study conducted in Eritrea reported that vancomycin 26.1%, rifampin 14.5%, and chloramphenicol 21.5% were the most sensitive drugs, while penicillin 95% and oxacillin 76.9% were the most resistant drugs.²² However, a study conducted in Madinah, Saudi Arabia, revealed that the most sensitive drugs were vancomycin, nitroxoline, and trimethoprim/sulfamethoxazole, while the most resistant drugs were penicillin and ampicillin.²⁴ This difference might be related to the difference in study patients and geographic region, in addition to the availability of antimicrobial agents tested, given that some drugs, such as vancomycin and gentamycin, were not included in this study because they were tested in less than 20% of GPB.

Regarding GNB, our data showed that amikacin, chloramphenicol, and levofloxacin were the most sensitive drugs, and ampicillin, amoxicillin/clavulanic acid and ampicillin/sulbactam were the most resistant drugs. This result differed from that of a study conducted in Khartoum, Sudan, in which amikacin was one of the drugs that showed high resistance to GNB.⁴ A study conducted in Bahir Dar, Northwest Ethiopia, reported that GNB had high sensitivity to ciprofloxacin,

while in concordance, ampicillin was the most resistant drug against GNB.³² Furthermore, a study conducted in Addis Ababa, Ethiopia, showed that GNB strains are highly sensitive to nitrofurantoin and meropenem, while in concordance, ampicillin is the most resistant drug against GNB.¹⁷ However, in a study conducted on Romanian female patients, the most sensitive drugs for GNB were imipenem and meropenem, while the most resistant drugs were levofloxacin, ceftazidime, and amikacin.³⁴ This difference could be linked to the difference in study patients and settings.

In particular, for *E. coli*, amikacin was the most sensitive drug, followed by chloramphenicol, levofloxacin, and ciprofloxacin, while ampicillin and amoxicillin/clavulanic acid were the most resistant drugs. These findings were in line with those of a study conducted in Khartoum, Sudan, which revealed that ampicillin, cotrimoxazole, and amoxicillin-clavulanic acid were the most resistant drugs.¹⁹ In addition, a study conducted in Addis Ababa, Ethiopia, showed that the most resistant drugs to *E. coli* were trimethoprim-sulfamethoxazole 85.7%, ampicillin 76.9%, and amoxicillin/clavulanic 71.4%.¹ Moreover, a study conducted in South Africa reported that the cotrimoxazole 65.1%, cefuroxime 27.3%, and amoxicillin-clavulanic acid 17.1% among the most resistance drugs.³⁵ In contrast, ampicillin and cefepime were the most sensitive drugs to *E. coli* in a study conducted in Yemen.¹⁸ However, this result differed from that of a hospital based study conducted in Khartoum, Sudan, in which the drugs most resistant to *E. coli* were ampicillin, cefepime, amikacin, and ciprofloxacin.⁴ These differences might be linked to differences in the study patients and settings, given that our study was laboratory based and encompassed outpatients and inpatients.

In particular, *P. aeruginosa* in this study exhibited high sensitivity to amikacin and levofloxacin, which differs from the findings of a study conducted in Khartoum, Sudan, in which amikacin exhibited a 69.3% resistance rate to *P. aeruginosa*.⁴ Another study performed in Yemen revealed that the most sensitive drug for *P. aeruginosa* was cefepime.¹⁸ However, in a study conducted in Madinah, Saudi Arabia, the most sensitive drugs were gentamicin and piperacillin/tazobactam, while the most resistant drugs were imipenem, meropenem, and levofloxacin.²⁴ This difference might be correlated with the difference in antibiotics tested.

Strengths and Limitations

As a strength of this study, we evaluated the prevalence and sensitivity patterns of uropathogens over a three-year period, which provided an accurate depiction of the prevalence and resistance patterns of uropathogens. Furthermore, the data were collected from the Pathology Center for Diagnosis and Research, Faculty of Medicine, University of Gezira. This facility works as the reference laboratory and encompasses all hospital settings at Wad Medani.

The current study has some limitations. In particular, (1) complete patient data were not available because this was a retrospective study, such as patient setting, inpatient or outpatient status, and comorbidity status. (2) Furthermore, a few bacterial isolates were not recognized at the species level, and a few antimicrobial susceptibility tests were not performed due to the acquisition of antibiotic disks. (3) In addition, some antimicrobial agents, such as vancomycin, linezolid for GPB, meropenem, and piperacillin/tazobactam for GNB, despite their useful therapeutic options, were excluded from the study because they tested for less than 20% of specific bacteria.

Conclusions

This study reported a moderate uropathogen isolation rate of 41.8%. *S. aureus* and *E. coli* were the most frequently isolated bacteria, the vast majority of which were from female patients. Remarkably, amikacin was the most sensitive drug to GNB and GPB, while the most resistant drug to GBP was cotrimoxazole, and GNB was ampicillin. Incorporating these findings allows for the planning of long- and short-term strategies as well as the use of effective empirical antibiotic choices for UTIs such as amikacin and levofloxacin.
