Page 2474, Results, Change in FPG section, line 2, the text "-1.09, 95% CI: -9.31, 11.77)" should read "1.09, 95% CI: -9.31, 11.77".




Figure 2 Forest plot of efficacy outcomes: (a) change in HbAIc levels from baseline; (b) change in FPG levels from baseline; (c) change in 2h-PPG levels from baseline.

Page 2482, Figure 2, figure part 2a, AGI row, confidence interval, the text, "(95% CI: -0.04, 2.80)" should read "(95% CI: -0.40, 2.80)"; figure part 2a, TZD+MET row, confidence interval, the text "0.69 (-0.02, 1.40)" should read "0.69 (0.02, 1.40)".
