Report of the President, Amanda Urias

- Showed list of officers and committee members, robust group of volunteers working on committees this year
- Report of the President
- Highlights of the year are in the written report, will let everyone else go into detail on their reports
- Has been a year of new programs, initiatives, ideas, board members
- Also been a year of affirmation and renewal, established our charter and revised bylaws, which will vote on in today's meeting
- Offered exciting programming for members and BU community, held true to mission identified in charter
 - o Promote diversity, inclusion, and community
 - o Build community belonging and friendship
 - Promote scholarly, intellectual and professional contributions of all who identify as women
 - o Support BU students by fundraising and awarding, scholarships
 - o Support grad students by serving as stewards of Fisk House and subsidizing grad housing
- Continued to establish our governance legacy
 - Submitted new charter to Provost ad interim, request to be a formally recognized unit of the Office of the Provost
 - o Been volunteer organization for nearly 70 years
- Extended invitation to incoming President, Dr. Melissa Gilliam to be BUWG honorary president, she did not accept to personally fill the roll
 - She will appoint someone from her team to be honorary president and be her representative after she is formally here in July
 - \circ $\,$ She agreed to be keynote speaker for BUWG/ WOCC Allyship event in early 2025 $\,$

Report of the Secretary, Holly Conviser

- Board Meetings Report
- 8 Monthly board meetings Sept 2023 April 2024
 - Meetings to report on monthly and upcoming activities
 - o Open to all members of BUWG and WOCC, attendance mostly officers, chairs, committee members

- o Held via Zoom on Fridays at 1pm, will continue same schedule next year
- Average attendance: 19-20 pp (last year 14-15)
- Sept, Nov, Feb largest attendance

Report of the First Vice President, Suzanne Maselli

- Programming Report
- Main task is to oversee programming efforts, easy lift thanks to help of other committees: WOCC, membership, governance, Fisk House, awards
- 16 in-person events, up a bit from last year
- June 2023 board planning retreat helped provide framework for this year's events
- Carolina administrative coordinator provided invaluable logistical support
 - o Made revisions/ updates to the Event Host and Communications guides
- Recruited new committee member Hannah Emmert
- Displayed list of all events, a few successful highlights:
 - o Pay equity lunch & learn with 3 Deans
 - o International Women's Day celebration
- One event on Medical Campus, would like at least two in coming year
- Annual awards lunch: Barbara Jones, Dean of the School of Social Work, will be speaker

Report of the Second Vice President, Jin In

- Membership Report
- Tripled committee membership: lots of collaboration, innovative ideas
- April 2024: 172 total members including 47 WOCC in 4 (condensed from 15) broad categories:
 - o 107 staff, 8 faculty, 10 retired, 47 non-BU (friends and lifetime members)
 - o Working on cleaning up data and starting fresh
- First ever membership survey with over 60% response rate
 - o Topics of most interest career development, pay equity and mentorship
 - Events held on both topics
 - Why joined BUWG #1 networking and community
 - Most valuable reason for being BUWG member networking and community
- New Ambassador program with 21 ambassadors
 - o Displayed list of names
 - o Meeting with them informally on why they joined and became ambassadors
 - Heartwarming and individual stories
- Ambassador toolkit with graphic design
 - o Helen created it to symbolize ambassador program
 - Snapshot of mission, possibly add to nametags
- Discussion of ordering formal nametags for BUWG board, committee members, and ambassadors

Report of the Treasurer – Korinne Dizon

- Financial Report
- Stewardship for over \$1.4M in spendable monies, 18 funds and principle endowment funds
- 2023-2024 financials:
 - o 2023 awarded \$135k in scholarships, awards and prizes
 - 2024-2025 will award \$257k in scholarships, awards and prizes, more aggressively planned spending of Kathryn Silber endowment

- o 16 events, expenses \$25k to date, \$30k expected by end of year
- Operating expenses \$1300, Fisk House \$2100
- Fund Balances
- Record keeping, make sure everything is charged in right place
- Some accounts we can transfer expenses to
- Carpenter Fund and Women's Council funds start charging for future events and transfer \$1000 overrun from Gallagher account
- Record keeping, expense tracking and consistency very important
- Fisk House endowment try to repurpose very large restricted balance for work with DAR, President's office
- Kathryn Silber endowment carries large balance of \$257k, generates \$70k in revenue or interest income
 O Hoping to spend down this and other endowment funds in coming years
- Establish budget for events and initiatives, be transparent with expectations

Report of the Women of Color Circle (WOCC) – Zephyre "Tess" Carrington-Waite and Jennifer Lloyd

- WOCC executive board has stayed the same for the last year
- Expanded committee, added chairs to each committee
 - o Membership: Rachelle Joseph
 - o Communications: Tasha Coughlin
 - Programming: Christa Rose (last year), will need to fill position going forward
- Committee members: Tahlia Bragg, Karen Coleman, Kadambari Rawal
- Meetings held via Zoom
- 47 registered members, 180 on mailing list, trying to convert to members
 - o Trying to align membership with BUWG annual membership
- Accomplishments:
 - o Juneteenth: First year collaborating with Faculty & Staff Community Network of Color (FSCN)
 - Networking breakfast
 - o Chat and Chew
 - o International Women's Day celebration
- Looking Ahead:
 - o Juneteenth collaboration with Faculty & Staff Community Network of Color (FSCN)
 - o Networking breakfast
 - o Conversations re: partnering on workshops with Organizational Development and Learning
 - o Allyship event: new President Dr. Melissa Gilliam speaker
 - Skipped allyship event this year due to lack of speaker

Report of the Governance Committee – Samantha Khosla

- Bev Brown reported on Governance 2023-2024
- Met this year as needed
- Organization is 68 years old, by-laws were last changed pre-pandemic, do not reflect Fisk House, many other deficiencies, needed modernization including language used for who is eligible for awards and membership, needed to be upgraded to be more inclusive
- Revised charter and overhauled by laws
 - \circ $\,$ Committee presented charter to the board for a vote at February board meeting
 - o Discussions on by-laws at February, March and April board meetings
 - o Board received draft of by-laws for first reading in March
 - Voted in April to approve and forward to membership for a vote at this meeting

- Charter is guiding principle of who we are, by-laws are the nuts and bolts ex. who can be a member, term limits etc.
- Membership received text on April 19, two weeks prior to this annual business meeting
- Charter initially approved in spring 2023, text revised during 2023-2024 session, will be incorporated into by-laws as section II Purpose
 - Board voted to approve revision at February board meeting, Khosla took comments and feedback into account and brought to committee and board for discussion
 - o Board approved revision of charter, full charter was read today
- Difference in opinion about inclusive language to describe gender
 - Board settled upon "all who identify as women"
 - o BUWG nearly 70 years old
 - o Using word "women" with modification is meant to be inclusive
- Charter and by-laws are living documents, should be reviewed and revised regularly to adjust language aligned with our mission of inclusion
- In 2024-2025 committee proposed to conduct focus groups with members of trans and non-binary community, possibly other groups also, discuss BUWG purpose and programs
- Goal to update by-laws to reflect our practices and make document clear and simple
 - Charters for committees and officers descriptions of duties, operational guidance, timelines
 - Revised article V: University President or partner or designee invited to serve as honorary president of BUWG
 - Broadened choices for President's office to be committed to BUWG
 - Quorum for executive board should be 51% and quorum for annual meeting should be 10%

- Allow for standing committees to have co-chairs
- Article IV, section 4 fiscal year same as BU: July 1 June 30
- Article VII, section 5 relax term limit for committee chairs
- Article IX renamed "Awards Annual and Housing"
 - Section 5 Fisk House committee review applications and recommend awardees
 - Section 6 Fisk House committee review applications for additional housing awards
- Committee presents 2024 by-laws to membership for consideration and vote
- VOTE: Updated BUWG Charter and By-Laws
 - o Bev asked for a motion to approve, any discussion, all in favor
- VOTE: Slate of BUWG Executive Board Officers, Committee Chairs 2024-2025
 - o Two committees will have additional chairs
 - Awards Krystie Dickson
 - Fisk House Sandra Grasso
 - Chairs and officers can change as needed, can bring to board at any time
 - o Bev asked for a motion to approve, asked for a second, all in favor

Report of the Awards Committee – Elizabeth Flagg

- Expanded to 11 members, 5 teams of 2 members each
 - o New members: McCabe, Deal, Rawal
- Solicit applications and select awardees for BUWG and BUWC scholarships
 - Administer Florence Engel Randall Fiction Awards
 - o Open to all undergrad and grad students
- Met in fall to review last year's rubric and made updates

- Carolina supporting annual awards lunch
- Doubled amount of funds able to award
- 213 complete applications
 - o 55 awards: most are \$5000, some are \$2500
- Total disbursement of all awards: \$257,500
 - \circ $\;$ Likely do award similar amount for few years while we spend down Kathryn Silber fund
- Awardees are informed, collecting their info, invited to annual lunch event
 - o Request awardees to submit photos and bios for BUWG website

Report of the Communications Committee – Maureen McCarthy, Sam Macriss, Kara Mullen

- Kara reported: website: reflection of work everybody does

Report of the Development Committee – Patricia Castaldo

- Two very successful development efforts
 - o Giving Tuesday November 28
 - Raised \$1070 from 12 donors for BUWG endowed scholarship fund
 - Giving Day April 3
 - Theme: 10 years of giving
 - Raised \$3533 from 33 donors for BUWG endowed scholarship fund
- Thanks to Communication Committee

- Increased number of donors for past 3 years
- First time sending thank you notes to donors
- Updated "Join us in Giving" page on website
- BUWG endowed scholarship fund campaign 56.75% of \$250,000 goal met
- Goals for upcoming year:
 - Recruit additional committee members 3 asks out now
 - o Enhance stewardship activities
 - o Explore match and challenge opportunities for Giving Day with board participation
 - Planned giving initiative to aid in meeting campaign goal
 - o 70th anniversary approaching perhaps messaging around that to meet fundraising goal

Report of the Fisk House Committee – Judith Sandonato

- November evening at Fisk House event: wonderful, heard from residents, shared their stories, student performances
- December established spring application timeline with Residence Life area Director Beza Begosew
- Fisk House charges added to webpage
- Fisk House residents' point of view pieces on website and LinkedIn
- Discussed creation of applications review rubric areas of evaluation: financial need, quality of reference letters, personal statement on why they wish to live in Fisk House and what they hope to contribute to community
- February met with financial and residence life administrators and housing directors to discuss housing charging process for summer 2024 and AY 2024-2025
- Student account charged in full then BUWG housing award applied to offset large part of expense
 - o FY 25 housing rate increase, students pay \$2100 per semester
 - o Summer 2024 monthly charges \$667
- Application went live January 1, deadline March 31
 - Review period: April 1 15, review April 16, students notified May 1
 - o 9 vacancies for 2024-2025
 - In total: 15 students and 1 RA reside in Fisk House (8 singles, 4 doubles)
- In future capture headshots and quotes of residents
